Preface:

One of the main objectives of higher education is to provide quality education to students and make them responsible citizens for the development of our society. This type of objective will be achieved if the institutions with similar aims and objectives come closer to share information and resources with each other for better growth and transformation. Collaborative activities will definitely help to identify the shortcomings, drawbacks and remedial measures. Thus, the colleges intend to collaborate with each other for the improvement of the students, community and society.

Harhi College was established in the year 1996 (Academic Session 1998-1999) and it is situated at a beautiful landscape on the bank of the river Charikoria of the rural Subdivision Dhakuakhana, P.O.- Gobinapur in the District of North Lakhimpur (Assam). Pin-787055. It is one of the premier institutions of Higher Education, covering almost Five (5) Gram Panchayats of Dhakuakhana Sub division, where most of the people basically belong to ST, SC, OBC and MOBC. Since inception the college has been imparting higher education and providing knowledge and skill among the students of Arts Stream. The college is situated at the HARHI region at a distance of about six kilometers from Dhakuakhana town in between the border area of Lakhimpur and Dhemaji Districts. The place where the college is situated enjoys a unique position in the field of art, literature and culture. The diverse tribes with their distinct dialects, customs, traditions and culture also make this area a variable paradise for the study of Art and Culture.

The college which began with a few number of students in H.S. and B.A. 1st year classes consisting of only five faculty members, is now a full-grown one in the rural Subdivision of Dhakuakhana. The strength of faculty members has now increased up to thirty four with sufficient academic acgrees. The student enrolment of this college is more than

200 right from Higher Secondary to B.A. classes in conventional mode. Besides, the college has another 200 students in open school under Assam Higher Secondary Education Council. B.A. and M.A. classes under Directorate of Distance Education, Dibrugarh University, in Non-conventional mode.

Objectives of MoU:

by particular, this MOU is intended to

- Exchange of faculty and student for improving educational environment.
- 2. Explore ways to cooperate in education and training.
- 3. Encouraging the use of ICT tools for teaching-learning process.
- 4. Assist the students in establishing various start-ups.
- 5. Exchange academic material and information.
- 6. Improve communication, co-operation and innovative ideas among students.
- 7. Facilitate effective utilization of the intellectual capabilities.
- 8. Explore the possibilities for developing joint research joint research programme and collaborations.

Functionaries:

For proper implication:

- 1. Each institute will constitute a committee to monitor and evaluate the functions of MoU.
- 2. A senior teacher will be designated as Liaison officer for monitoring the committee.
- 3. Both the Liaison officer will prepare an annual plan with the consultation of the head of the institutions.
- 4. The Liaison officer will have to submit a report annually to the head of the institutions and Head of the institutions will produce that report to the committee constituted for monitoring the function.

Scope of the MoU:

- 1. Both institutions believe that close co-operation between the two would be a major benefit to the student community to enhance their skills and knowledge.
- 2. Both institutions will emphasize on teaching and training methodology.
- 3. The interaction between two colleges will give an insight into the latest developments of the syllabus/course.

Period of Agreement:

- 1. The validity of the agreement is three years from the date of commencement.
- 2. After satisfactory completion of three years, agreement may be extended to next year.
- 3. Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of termination, both parties have to discharge their obligations.

Declaration:

The provisions cited in the above MoU are thoroughly discussed and reached at the consensus that both the institutions will follow the provisions and implement the same by heart and soul.
